



The U.S. Constitution mandates that the nation count every person in America every ten years, and companies rely on the accuracy of the census for a variety of **reasons. First.** it ensures that federal dollars are allocated appropriately and where they will have the greatest impact. More than \$800 billion from 300 federal programs, such as the Highway Planning and Construction Program, are distributed each year based on population data collected by the census.1 Census data also helps direct funding to key programs for disadvantaged children that support the development of the current and future workforce, such as child care for working families.<sup>2</sup>

**Second,** the census is a source of essential data for businesses, providing demographic information to assess potential employees, customers, products and markets. **Third,** the count is used to determine political

representation at the local, state and national levels, so accuracy is important for appropriate governance. For all of these reasons, ReadyNation is working with America's business community to call for both robust support for the 2020 census and widespread participation in this critical civic duty.

# The census ensures the efficient allocation of taxpayer dollars

Each year, the federal government allocates billions of dollars to states and localities based on information derived from the census. These taxpayer dollars fund programs of direct benefit to businesses, such as the \$38 billion Highway Planning and Construction program that allows states

to construct and repair highways and bridges.3 Moreover, in order to develop a highly-skilled future workforce to compete in the global marketplace, we must invest in high-quality children's programs that help the next generation achieve academic, career and life success.4 Data from the census allows for effective allocations for programs such as Head Start, child care and children's health insurance. 5 Children under age five, particularly those from disadvantaged families, are the age group most likely to be undercounted, with more than one million missed in the 2010 census.<sup>6</sup> Without an accurate census, funds for these programs may be misallocated, with valuable resources failing to reach the constituencies for whom they can have the greatest impact.

## American businesses rely on the census for decision-making

Businesses rely on census data to inform a variety of strategic decisions.7 They use census data when identifying new locations to determine if the local workforce has the level of education needed, or if the local population has the demographic characteristics of the company's target customer base. In addition, market research conducted by individual businesses or market research firms often utilize census data. The Census Bureau's Census Business Builder website provides free census data to businesses.8 This tool includes a Small Business Edition that offers information about "potential customers and similar businesses for those starting or planning a business," as well as a Regional Analyst Edition with data on "residents and businesses in an area for regional planning."

Effectively allocating public resources to the intended children, families and communities requires an accurate census.

Information from the census is used to ensure appropriate political representation at the local, state and federal levels - for example, to determine how many U.S. Representatives are allocated to a state. Businesses with deep interests in their state, or simply in good governance, want accurate numbers to fulfill those goals.
